second Affidavit of Giuseppe Loforese both sworn on the 13<sup>th</sup> day of June 2023, the Affidavit of Nicola Maria Fioravanti sworn on the 15<sup>th</sup> day of June 2023, the Affidavit of Elaine Long sworn on the 19<sup>th</sup> day of June 2023, the Verifying Affidavit of Giuseppe Loforese sworn on the 13<sup>th</sup> day of October 2023, the Affidavit of Fabrizio Soru sworn on the 12<sup>th</sup> day of October 2023, the Second Affidavit of Elaine Long sworn on the 16<sup>th</sup> day of October 2023, the Affidavit of Nicola Maria Fioravanti sworn on the 16<sup>th</sup> day of October 2023, the Third Affidavit of Elaine Long sworn on the 18<sup>th</sup> day of October 2023, the Fourth Affidavit of Elaine Long sworn on the 26<sup>th</sup> day of October 2023 and the documents and exhibits referred to in said Affidavits, including the Scheme

AND UPON hearing Counsel for the Petitioner

AND there being no appearance in Court by or on behalf of any other party

IT IS ORDERED


1. that the Scheme be sanctioned pursuant to the provisions of Section 13 of the Assurance Companies Act 1909 (as amended) and Regulation 41 of the European Union (Insurance and Reinsurance) Regulations 2015; and
2. that notwithstanding any provision to the contrary in the Scheme, the Scheme shall take effect at 00:00:01 Italian Standard Time (UTC+1) on 1 December 2023 (or such later date as may be specified in the deed of merger approved by the Italian notary in the related cross-border merger of the Petitioner and Intesa Sanpaolo Vita S.p.A) (and for the avoidance of doubt, this date and time shall by virtue of this Order and without the need for any further act or instrument be the Scheme Effective Date for the purposes of the Scheme (and the Scheme shall be construed accordingly))
